Subject: **Reduction in pay to the DRTTAs recruited on and after 1.1.2007 due to 2<sup>nd</sup> PRC.**

Dear Sir

It is regretted that the repeated plea for the inclusion of the issue of pay reduction of DRTTAs recruited on and after 1.1.2007 in the committee formed under your Chairmanship to address the similar issue of DRJTOs recruited on and after 1.1.2007 is met with total uncompassion.

It is now learnt from the website on AIBSNLEA that the said committee under your chairmanship has decided to extend 4 or more additional increments in the new basic pay to the DRJTOs recruited on and after 1.1.2007 to compensate the loss in the salary due to 2<sup>nd</sup> PRC.

Though we are still of the view that the 30% fitment given by 2<sup>nd</sup> PRC should be extended to all the employees in BSNL who were working till the date of implementation of 2<sup>nd</sup> PRC but if any special dispensation is given to the executives other than 30% fitment to compensate the loss in salary due to 2<sup>nd</sup> PRC the similar special dispensation without any prejudice and dilution must be given to the non executive (DRTTAs) who are also facing loss in salary and allowances due to 2<sup>nd</sup> PRC

**Thus I urge you once again to broaden the concept of committee under you and take the decision on the pay anomaly of DRTTAs too to avoid further delay and any unrest among them.** An early action on this issue is required.
